## INCORPORATION OF TWO WHOLLY-OWNED SUBSIDIARIES IN INDONESIA

The Board of Directors of Interra Resources Limited (the "**Company**") wishes to announce that the Company has on 25 June 2025 incorporated two wholly-owned subsidiaries as "Penanaman Modal Asing" in Indonesia with the following particulars:

Name Place of Incorporation Authorised Capital Issued Capital Principal Activities	:	PT Interra Renewable Energy (" <b>IRE</b> ") Jakarta, Indonesia Rp. 10,000,000,000 comprising 10,000 shares Rp. 10,000,000,000 (approximately USD 616,257) Mining services business, which includes transportation and rental of heavy vehicles and/or equipment (with and without operator) to support businesses in the mining industry such as mining contractors and mining license holders

IES is 99.99% and 0.01% held by the Company's wholly owned subsidiaries, Goldwater TMT Pte. Ltd. ("**GTMT**") and Interra Resources (Borneo) Pte. Ltd. ("**IRB**") respectively. IRE is 99.99% and 0.01% held by PT Interra Resources Indonesia Investment (which is in turn 99.99% owned by GTMT and 0.01% owned by IRB) and IRB respectively.

The aforementioned investments by the Company in IES and IRE were funded by internal resources and are not expected to have any material impact on the consolidated net tangible assets per share or earnings per share of the Company for the current financial year ending 31 December 2025.

None of the Directors or controlling shareholder of the Company have any interest, directly or indirectly, in the aforementioned investment, other than through their respective shareholdings in the Company (if any).
